

Strategic Plan for UXO Clearance in Lao PDR, 2009 - 2012

PROGRAMME VISION: A LAO PDR WHERE:

- ***COMMUNITIES CAN REQUEST AND RECIEVE NATIONAL UXO CLEARANCE RESOURCES TO REMOVE UXO THAT HAVE BEEN DISCOVERED AND WHICH PUT THE POPULATION AT RISK.***
- ***POOR OR VULNERABLE COMMUNITIES CAN REQUEST AND RECEIVE THE CLEARANCE OF UXO CONTAMINATED LAND WHICH IS REQUIRED FOR THE ENHANCEMENT OF LIVLIHOODS***
- ***WHERE APPROPRIATE THAT ALL DEVELOPMENT PROJECTS AND COMMERCIAL PROJECTS PLAN AND INCLUDE DEALING WITH UXO AS PART OF THEIR PROJECT DESIGN AND BUDGETING***
